Planning your donation for later?

WILL BEQUEST

Donations can be designated to Mennonite Brethren Biblical Seminary through a will. These gifts can include cash, real estate or other kinds of property.

Could this benefit an estate?

Yes! Charity designation may significantly help to offset income tax on an estate. Not all estates have the same tax implications, your advisor or lawyer can help you with your plan.

Here's one example:

REGISTERED FUNDS

Donations can be made to MB Seminary through registered accounts such as a:

- RRSP

- RRIF

- TFSA

There are two ways to gift registered funds: include this donation within a will to ensure a bequest to the seminary and tax benefit for the estate, or name MB Seminary as beneficiary (or alternate beneficiary) to avoid probate.

LIFE INSURANCE POLICY

Designating MB Seminary as beneficiary on a life insurance policy is a great way to leave a lasting legacy. Designated gifts from a life insurance policy are not subject to probate!

This can also be done through the transfer of an insurance policy. Both options have estate tax benefits. Both options help the mission of MB Seminary.

PUBLICLY TRADED SECURITIES

Did you know donating publicly traded securities is one of the most tax efficient ways of giving to charity?

Donations may include:

- Mutual funds
- Stocks
- Bonds

and must be held outside of RRSP, RRIF or TFSA accounts. These donations are transferred in-kind to MB Seminary in order to minimize tax on capital gains when sold. The shares will be sold and you will receive a tax receipt, avoiding capital gains tax.
